Mr. Williams,

This is an official notice and you shall **Cease and Desist** from your engaging, participating, and conspiring in: trespassing; larcenies; logging; timbering; severing; poaching; hunting; shootings; destruction of property; acts of violence; threats of harm and death; blackmail; coercion; intimidation; slanders; liables; defamations of character; creating, initiating, participating in unwanted publicity; injury to Corporate and subsidiary entities names, reputations and value; fraud; identity theft; unauthorized use of names, logos, symbols, and corporate work product; false claims; unauthorized taking, theft, transport, possession, storage, sales and conversions of Corporate property and assets where ever it has occurred; along with other criminal, injurious and liability causing activity related to and effecting National Alliance a Virginia non-stock corporation and it's subsidiary entities such as but not limited to National Vanguard Books Inc., Cosmotheist Community Church, Resistance Records; and upon the property of and deeded to National Alliance, and Cosmotheist Community Church in Pocahontas County, West Virginia.

You shall send to me forth-with upon receiving this notice ALL documents; contracts; contacts you have had or know of related to any sales, commerce, trade, exchange, conversion of Corporate property and assets since 2013. To included information on how unauthorized people such as yourself or connected with you have come to have access to this property, and have engaged in unauthorized prohibited illegal actions and crimes such as but not limited to those listed in previous paragraph, and unauthorized illegal presence and occupation of Corporate property, various States misdemeanors and felonies, Federal crimes, irreparable harm and damages.

To include full itemized information on all arraignments you have entered into, and have knowledge of; instructions, access, and on the sales, conversion, removal, compensation, payment, benefit, monies, exchange, barter, trade, or services rendered; and the compensation disbursement to and from between any and what parties with dates for all of such activities in full of Corporate property and assets of National Alliance and all it's subsidiary entities (to included but not limited to National Vanguard Books Inc., Cosmotheists Community Church, Resistance Records, Cymophane Records, Unholy Records, etc..).

To include full and complete count of ALL animals, trees, plants, fauna that have been destroyed, killed, injured, stumpage, severance, or removed from it's properties and land.

To include fully and itemized what benefit, compensation, monies, trade, commerce, exchange, barter, or services that have been given or received through these acts to yourself or other persons that shall be listed, detailed and with dates.

Listed and non-listed actions each count are severe liabilities, illegal, and connected to violations of State,

Federal, and International regulations, laws, codes, acts, treaties; and involve many different Agencies. These properties have upon them, and are previously officially cited and known to contain regulated, protected, and endangered species. There are currently several State and Federal investigations in process.

The National Alliance and it's subsidiary entities does not authorize or condone criminal activities, and most certainly can not have them done on their property which causes loss, irreparable harm, damages, and liabilities for them. We will continue to be proactive We will continue to assist authorities, and protect the interests and future of the National Alliance and it's subsidiary entities.

You shall provide information on your being given cash, checks, money orders, wire transfers, electronic funds, or any other form of conversion, compensation, donations, gifts, goods, items, etc.. from any person or entity believing they were giving such to or for the benefit of the National Alliance a Virginia non-stock corporation or any of it's subsidiary entities. You are to fully account for these monetary amounts, and compensate the Corporation &/or entities via sending to me in my authority and capacity for them the whole sum, and to surrender any item/goods/asset of what you have taken into and through consequence yourself under such fraud and identity theft.

You may scan and email some of these items you must provide to myself on behalf of the Corporations and entities immediately.

No person is to enter in, or be upon, or be around the property of National Alliance, and Cosmotheist Community Church without MY explicit instructions, and written permission and authorization.

William White Williams & Svetlana Williams have no such permissions or authorization; and are prohibited and banned from all National Alliance and Cosmotheist Community Church properties.

All and on going poaching, shooting, timbering, lumbering, and tree removal, sales has not been authorized, and is profoundly illegal. It is not authorized, permitted, licensed, certified, noticed, contracted, or properly insured according to Federal, and State requirements.

Evidence has been provided by many different sources that during these unauthorized, prohibited, illegal, dangerous, highly regulated activities connected but not limited to: trespassing, poaching, shooting, logging, timbering and other unauthorized activities persons have been intoxicated and impaired via alcohol, prescription drugs, and illegal and controlled substances and drugs.

The National Alliance and it's subsidiary entities has a strong no tolerance policy against such, and does not allow the possession of or use of; alcohol, or illegal and controlled substances and drugs on it's properties. Nor does it allow people who are under the influence of such upon it.

You shall properly transfer the Title to National Alliance (or with me as the co-owner in my name) and return and surrender the Corporate paid for black Dodge Dakota pickup truck that currently has the TN license plates S76-49Z. You are to send to me the Title and registration for the Corporate 2002 red Dodge Dakota pickup truck.

You shall cease and desist from initiating and continuing your fraudulent lawsuits you file in your private name against Corporate and entities Directors, Officers, and Staff. They are more of your continued acts of abuse, threats, States witness intimidation, obstruction of justice, and attempts to continue your pattern of committing continued fraud, and larcenies of Corporate and entities property. All items you have listed prior and presently you have no rights or claims to, as they are all documented, witnessed, to fully owned corporate property and assets and property.

You shall surrender to me or to my designated Corporate staff, all corporate records, to include but not limited to: ALL Articles of Incorporation & Bylaws (to include any and all proposals, alterations, amendments, repeals, adoptions, drafts, resolutions); minutes, appointments to office, resolutions, notifications, books, ledgers, accounts, 3 Corporate Seals; and full and complete information and databases in digital format of past and current members, honorary members, supporters, customers, donors, suppliers, re-sellers, publishers, contractors, printers, associates, service providers etc., for National Alliance, National Vanguard Books Inc., Cosmotheist Community Church, Resistance Records, Cymophane Records, Unholy Records; and the corporate laptop that you took possession of 2014 that had corporate databases on it.

You shall turn over the full transfer, passwords, and contact information for the Corporate owned property webpage, domain Natall.com.

You shall cease and desist from using the National Alliance, National Vanguard Books Inc., Cosmotheist Community Church, American Dissident Voices' names, in variations or abbreviations (to include "National Vanguard"); any Corporate or entities symbols, logos, endicia, images, pictures, videos, audios, copy-written material, writings, and all other Corporate work product and property in association that is associated with then in relations with yourself personally, or with the private membership club, created and connected to you and Kevin Alfred Strom, and the Tennessee incorporated "church" Cosmotheist Alliance Church, your associated P.O. Box 172, Laurel Bloomery, TN 37680; and in any such bulletins, newsletters, publications, web-pages, audio, video, forums, blogs, avatars, memes, watermarks, signatures that are connected with either of you.


You shall surrender all digital files, and masters, work product supplies, components, finished products, books, booklets, pamphlets, and mailing supplies, labels, label machine, printers, computers, laptops, cameras, scanners, paper cutters, bulletin folders, all CDS and publications that belong to the Corporation and it's subsidiary entities, and with which it's income, revenue, gifts, donations, or lines of credit in any of their names was used to order, create, manufacture, print, assemble, purchase.

If you are detained, incarcerated, unavailable, incapacitated in any manner Svetlana Williams who currently has full, complete access to all things requested in this document shall Provide all of these, since they are currently located without authorization or permission in your TN home, on your property, or within both your control and access, and have been previously, consistently, on-going denied to the Corporate and entities Boards the rightful owners of all such.
